### The World Federation NGO status

- Received an NGO status, as a Special Consultative Status, with the Economic and Social Council (ECOSOC) of the United Nations in July 2007.
- Developed a four stage process for taking forward the NGO agenda.
- Have developed a three-year work plan that was adopted by the Executive Council in 2009.



### Four Stages of NGO Work

- Stage 1: Enhancing the Structure
  - Policies and Documentations and statements. Developing advocacy and M/E policies.
- Stage 2: Creating Sustainable Networks
  - Membership of various organisations
- Stage 3: Extending Influence
  - Attending and representing at various meetings
- Stage 4: Seeking external resources
  - Applying for funding and seeking collaborative partners.



### **Membership of Other Bodies**

- British Overseas NGOs for Development (BOND)
  - BOND is a UK membership body for non-governmental organisations (NGOs) working in international development.
- The World Association of Non-Governmental Organizations (WANGO)
  - The World Association of Non-Governmental Organizations (WANGO) is an international organization uniting NGOs worldwide in the cause of advancing peace and global well being.
- The Conference of NGOs in Consultative Relationship with the United Nations (CONGO)
  - An independent, international, non-profit membership association of nongovernmental organizations (NGOs). It facilitates the participation of NGOs in United Nations debates and decision-making.



### **Stage 3: Extending Influence**

- DFID consultation exercise
  - DFID White Paper Consultation 2009 Resulted in double funding to faith based organisations from the UK Government from 2010 and more interaction of the activities with faith based organisations.

  - NASIMCO in final stages of appointment




# Stage 4: Sharing resources and obtaining funds

- Assistance in the application of funds.
  - Hussaini Foundation has been successful in securing a \$18,000 grant for the construction of a housing project for the poor community in Sindh
  - Hussaini Foundation has applied for £41,000 for an education training of primary school teachers in Northern Pakistan.
  - Will continue to inform and assist organisations on opportunities for grant funding.

### **Monitoring**

- Tracking progress in accordance with previously identified objectives, indicators, or targets (plan vs. reality...)
- "going to plan"

#### **Evaluation**

- Assessment of the relevance, performance, efficiency and impact of a piece of work with respect to its objectives
- Systematic, data based -Often can use data from monitoring as one source of information
- E valua tion
- Can address "how" and "why" questions
