As per past practice Senior Citizens Forum arranged visit to Jhampir to participate in Azadari on Sunday the 22nd February 2009. About seventy male and female members participated. The transport was arranged from Bhojani Hall in Soldier Bazaar and Mehfil-e-Murtaza P.E.C.H.S. the bus left Karachi at 8:30 a.m. the seniors were first taken to wind power project being set up by Zorlu Enerji Pakistan Ltd., (a Turkish company) at Jhampir. The General Manager of the company and engineers at the site gave warm welcome to the seniors. Mr. Ali Raza T. Lakhani addressed the seniors explaining how electricity is generated. He traced the history of invention and work of the scientists on the subject. He also informed various methods of generating electricity. The participants then asked company the seniors were taken to the power generating plant.. At present four wind mills are ready for operation and others are being installed. We are thankful to Mr. Ali Hassan Bhojani for arranging the visit to the wind power plant. Our gratitude is also to the Company particularly its Administration Manager Shah Jawad for showing the working of plant.

The seniors then reached Imambargah of Jhampir to attend traditional Majlis there. Renouned poet Syed Sibt-e-Jafar Zaidi and his companions rendered Marsiakhwani. Majlis was recited by Syed Muzaffar Husnain Zaidi (from India). At the conclusion of Majlis an imaginary scene of poet Bashir was presented announcing the

return of Ahlul Bait (S.A) to Madina. An old man (acting as Bashir) emerged from rear end of the gathering carrying Alam (Standard) and shouted "O people of Madina, this city is not worth living because Imam Hussain (A.S) and his companions were martyred at Karbala and his family, who was tortured and humiliated, has returned to Madina. Some boys asked Bashir what happened to Aun, Muhammed, Ali Asghar and other children who had gone with Imam Hussain (A.S) but are not back with the returned group. Bashir narrated all the tragic events of



Karbala particularly relating to misery of children in reply to the questions put up by the boys. Thereafter the participants of Majlis started beating their chests (Matam) to mourn the atrocities inflicted on Ahlul Bait (A.S).

In the evening a procession was taken out with Tazia and Alam which passed through the streets of the village. After taking Niyaz specially arranged by the management, Mr. Ali Raza T. Lakhani addressed the seniors. He said Azadari was first commenced here in the year 1948 when Syed Murtaza Zaidi and Syed Mustafa Zaidi (cousins) settled in Jhampir after migrating from India. They bought acres of land and built Imambargah complex for the purpose of Azadari. The descendents of these two Syeds have now



settled in big cities of Pakistan but have maintained the building complex and tradition of arranging religious programs during the months of Muharram, Safar, Rajab, Shaban, and Ramazan. He also appealed seniors to contribute towards the Niyaz which is fed to more than one thousand people gathered here. The

collection of Rs. 10,000 from the seniors was presented by Mr. Ali Raza T. Lakhani to Syed Ijtiba Zaidi (grandson of Syed Mustafa Zaidi).

The seniors were also taken to Kalari Lake adjoining the village to enjoy the scenic beauty and also to see the tomb of a Pir (Muslim saint) and temple of Jham (a Hindu Saint) Mr. Ali Raza T. Lakhani explained that the name of the city was probably coined from both these names i.e. Jham+Pir.

On their return to Karachi the seniors had stop over at a restaurant on the highway to offer prayers and have tea. They reached Karachi at 9:00 p.m.

# VISIT TO IMAM BARGAHS

The Senior Citizens Forum arranged a visit to local Imam Bargahs where replicas of holy shrines in Iraq are constructed. Transport was arranged on 25th January 2009 to carry the seniors from Bhojani Hall and Mehfil-e-Murtaza. The first visit was made to Imam Bargah Shah Najaf on Martin Road where Rowza of Hazrat Ali (A.S) is constructed. The seniors recited ziarat (salutation) at the zareeh. Mr. Ali Raza T. Lakhani explained the history of construction of shrine of Maula Ali (A.S)

at Najaf and the events related to that shrine.

The next visit was to Imam Bargah of Rizviah Society where replica of Bibi Fatima's tomb is constructed. The seniors listened to Nauhakhwani and had Matam. Here also Mr. Ali Raza T. Lakhani narrated the history of the graves in Jannatul Baqi in Madina and the events related to the same. The seniors prayed for reconstruction of tombs which were destroyed by the local government.

The seniors then proceeded to Imam Bargah Babul Ilm in North Nazimabad where the replica of Hazrat Abbas' shrine in Karbala is constructed. Here also the seniors attended Nauhakhwani. Niyaz was also served.

Lastly, the seniors reached Imam Bargah in Ancholi Society to visit the replica shrine of Imam Hussain (A.S). The male seniors offered Namaz-e-Zoharain in congregation at Majlis Khairul Amal while female seniors offered prayers in shrine

building. After completing the Namaz, the seniors had Nauhakhwani and Matam. The Ziarat Waritha was recited by Mr. Shiraz Onali.
