Message from the President

As I pen this message to share with the Community, I reflect on the progress we have made in the last year and thank the Almighty for guiding us and helping us.

The World Federation embarked on an unprecedented strategic planning exercise through which it engaged the Community grassroots around the world. The results of the strategic planning gave us a clear direction and focus whilst at the same time setting many new challenges ranging from key priorities that the Community felt needed greater attention to areas such as the style, content and frequency of our communications.

Additionally, the advent of the Strategic Plan also brought about tremendous interest among the young professionals of our community who are increasingly eager to play their part in serving the community and humanity at large. We have endeavoured to create an optimum environment at the secretariat for them to come forward to serve.

Clearly all this has meant a significant change to the way we function. We have started to challenge our thinking, our approach, our methodologies, our systems and processes; and every facet of this organisation has risen to the challenge of meeting the ever-growing expectations of the Community. The organisation is re-orienting its practices so it can work in an increasingly efficient way and in the process, we are building competencies and sustainability within the organisation through this new way of working.

The Strategic Plan required the secretariat to engage the regional federations, jamaats and other institutions to address and deliver on the key issues highlighted by the grassroots around the world. We asked each region to provide us with a three-year implementation plan and we now have these for Africa, Guiarat, Pakistan and North America.

The Boards and Desks of the World Federation are therefore focussed on delivering these implementation plans by working together with our members and other organisations to meet the individual and collective needs of our community.

I will leave you with some final thoughts in an area that I am most concerned about. The burning issue is one of erosion of tableegh in our own communities. The issue is no longer of language because our muballigheen can communicate with us in various languages, including English. The key to addressing the issue is to ensure that Islam is considered as relevant to people lives and that our techniques of imparting Islamic knowledge are aligned to the recipients' experiences in their different societies and geographical areas.

Our experiences are and will be different - our values are and should always be Islamic. So the challenge for us all is how our institutions start to recognise this and change their approaches.

To that end, the initiatives that the World Federation Islamic Education Board has undertaken to address this challenge include:

- introduction of a GCSE syllabus in our Madaris & community schools;
- · short term courses in Qum for our youths:
- · engagement with the Hawza-e- Ilmiyah in Qum to influence relevant syllabus to meet our needs;
- · collaboration with Islamic teaching institutions such as Islamic College for Advanced Studies, Al Mahdi Institute and others.

I must emphasise that success relies on our combined efforts, a global partnership to face this challenge. The next stage of development will involve identifying partners with whom we share a common purpose and start working with them to deliver the agenda ahead.

With the Brampton Accord, we as a community have achieved unity to work under one common Ijaza for collection and disbursement of Khums, so let us now centralise our resources both human and

The delegation was involved in the following activities during their visit:

Visit to Majma-e-Jahani-e-Ahlul Bayt (World Ahlul Bavt Assembly)



Throughout the trip, the delegation was the official guest of Maima-e-Jahani (World Ahlul Bayt Assembly). They had a day's meeting with the officials of Majma including their Secretary General Hujiatul Islam Muhammad Hassan Akhtari, who appealed to the World Federation to join Majma for collective efforts in education, eradication of poverty and the spread of the message of Ahlul Bayt (AS). He also appealed to the World Federation to look into establishment of an International University. A brief insight into the three phases of the evolution of the World Federation was then given, namely:

- · Establishment of our centres world-wide
- · Assisting in alleviation of poverty and illiteracy, building schools etc.
- · Extending activities beyond the Khoja world.

Following the meeting, an agreement was reached with the Majma to cooperate on the following common areas with immediate effect, and to continue to expand in different areas in the coming months. Publications

- · Short Summer Courses
- · Contacts with the Iranian Red Crescent Society
- Fast tracking the admission process for our students by the Iranian Ministry of Foreign Affairs.

Visit to the International Centre for Islamic Studies (Markaz)

Dr. Hassam emphasised on the need for unity and helping our youth with the difficulties they are facing in society. He also took the opportunity to thank both the ICIS and Madrasah Imam Khomeini for their support and warm welcome they gave to the students in the recent short course.

An agreement was made with ICIS, whereby ICIS will accept thirty-five students who have been recommended by IEB and who have the entry requirements for the Introductory and BA Degree Course. In addition, ICIS will hold a six-month course every year for a maximum of twenty-five students who would be recommended by the IEB. In return, IEB shall organise a three-month course in England for fifteen officials and specialists of the ICIS for the purpose of completing their spoken English training.

This meeting was held to finalise the plans for the Hawza project in Bam. The meeting was held at Madrasah Faiziya, Qum at the office of Sayyid Hashim Bushehri. Sheikh Asgar Asgari, the Friday Prayer Leader of Bam, welcomed the delegation and thanked the World Federation for the Muharram and Safar tent project, saving that this was an honour for Shias and adding that it was given global exposure.

Visit to the Centres run by the office of Sved Jawad Shahristani in Qum

The delegation was given a tour of the various centres of Avatullah Seestani by Abu Asthmar, the Chief Accountant of the Representative of Avatullah Seestani in Iran and Sayyid Jawad Shahrestani. Some of the centres visited included the Eve Hospital, the History Library, Ahlulbayt Global Information Center, the Old Manuscript Centre, and the Astronomy Centre.

Meeting with students from our community

The delegation met most of our community students in Ourn at Dar al-Zahra (AS). In his address to the students. Sheikh Safder Jaffer announced the plans for an IEB Office to be established in Qum with Sheikh Mohammed Ali Ismail running it. Dr. Hassam then gave a short talk, stressing that the IEB Qum Office is for all of them. This was followed by an open forum in which issues relating to ICIS meeting as well as other matters concerning studying and living in Qum were discussed.

Visit to Imam Sadiq (AS) International School, Qum

The delegation visited this school, which currently has about three hundred students from sixteen different countries and teaches up to the fourth class of Montessori, implementing the Oxford Education System with some additional classes on Islamiyat, Persian, Urdu and Quran. The School is in need of a qualified. experienced Principal, a bigger place, books and school uniforms for the children.

Meeting at Jamiat-az-Zahra - Girls College in Qum

Sheikh Mohammad Ali Shomali, Director and Head of International Students, briefed the delegation that the short courses have proven to be very successful and that there is a great demand for them. He presented the delegation with a set of CDs covering some of the lectures taught in this year's short course, which some of our girls attended.

Meeting with the President of Iranian Red Crescent

A meeting was held with the President of Iranian Red Crescent Dr Ahmed Ali Noorbala. He congratulated Dr Hassam on his appointment as a Muslim and Asian Trustee at The British Red Cross, Dr Hassam briefed Dr. Noorbala on the initiatives of World Federation in providing for the needs of those affected by the earthquake in Bam.

World Federation has taken on the project to build a much needed Hawza that will use a contemporary syllabus aimed at creating Religious leaders (Aalims) for the various towns and villages surrounding Bam. There is a particular need to strengthen the Cultural & Religious base of Bam due to it's location at the cultural front line protecting the country against infiltration by the missionary works of other schools of thought from nearby Baluchistan and Sistan.

At a ceremony to sign the Memorandum of Understanding defining the project and its parameters, the Head of Hawza Ilmiyya for Iran, Sayyid Huseini Bushehri commented that it was indeed unique to see people who had travelled a great distance from their homes to come to a far off place to assist their brothers in faith. He commended the World Federation's efforts and congratulated the entire community in this regard.

The Imam Juma, who is a direct appointee and representative of Avatullah Khameini in Bam, said the prompt action of the World Federation by providing 14 centres, ensured the commemoration of the events of Kerbala took place with fervour as well as provided centres for congregational prayers and other communal activities. He added that although many NGOs and international organisations had extended support to the people of Bam, the World Federation had played a pivotal construction of the Hawza in Bam with Syed role by addressing much needed support in this particular area of cultural. A Review of a century old relationship. between the Maraje and the Khoja Community.

"The Maraje have nurtured and supported the leaders elected by our Community demonstrating that they understand that a leadership emerging from within a Community is best placed to understand and address challenges."

The relationship of the KSI Community with the maraie goes back as far as the the period of early conversion of the Community to the faith. To understand the context in which the very first time our Community had interaction with the Maria, it is, first, necessary to have a brief historical review.

Soon after the arrival of the Aga Khan in India, and owing to the greater control exercised by the Aga Khan in the affairs of the community, certain groups dissented. This resulted in a number of prominent Khoja families being ousted from the Jamaat Khaana. In the early 1800s some of these 'outcast Khoias' went for Zivarat and while in Naiaf they met the Multahid of the time. Sheikh Zainul Aabedeen Mazandarani. During their discussions Ayatullah Mazandarani recognized that there was a need for a muballigh to teach them the agaed of the Shia Ithnaasheri faith. Soon after and at the behest of Ayatullah Mazandarani a South Indian muballigh, studying in the hawza, (called Mulla Kader Hussein) returned to India. His efforts resulted in more and more Khoia families leaving the Ismaili sect and accepting the Shia Ithnaasheri faith. From these few dissenting families some of whom had to undergo considerable hardship (and two of them gave their lives), the community has now grown to well over 120,000 Khoja Shia Ithna-asheries. The overall number is still very small when considering that there are an estimated 300 million Shia Ithna-asheries in the world

It must be acknowledged that since those days, the KSI Community has been blessed with the support and patronage of the Maraje, by way of religious guidance as well as the various mujtahedin allowing the use of hukook funds for establishing imambargas and tabligh projects. At the same time, the KSI leaders endeavored to educate the Community not only to pay its hukook funds but also in centralizing its activities and projects. The leadership has always been proactive in communicating the Community's challenges to the Maraje and seeking guidance - which it always conveys to the mumineen, through its network of Jamaats around the world.

In these days of the Imam's (AS) concealment, it is the prerogative of the Maria to grant an jiazat, or a wakalat. for the use of hukook. (When a payer is allowed to use a certain percentage of Sehme Imam for his own liability towards Khums and for the prescribed purposes it means that he has an ijazat. However, when a person is appointed to collect Khums from the believers and then dispense with it, partly or fully in the manner prescribed by the Maria, it means that he has a wakalat.)

In the the Khoia Shia Ithna-asheri Community, individuals holding liazat are 'known to have existed since the times of Marhum Ayatullah Syed Abul Hasan Isfehani (d. 1945) and Marhum Ayatullah Syed Husain Burujardi (d. 1960). In fact, the latter had sent his Wakils from Irag to East Africa and had also appointed certain reliable, and pious. local Momineen to perform the work,' [1]

At an organizational level and for the very first time in the history of the Community, the then Président of Africa Federation, Marhum Haji Ebrahim H. Sheriff (d. 1960), was granted a wakalat by Marhum Ayatullah Syed Muhsin El Hakim, (d. 1970).

This was a turning point in terms of centralization as well as a structured relationship with the Maria, 'Thus, a new era in our Community had dawned. Individuals, families and traders who were hitherto averse to paying Khums, became conscious and inclined.' [2] Subsequently, Marhum Hassanalibhai M. Ladak (d. 1967) followed by Marhum Haii Mohamedali Meghii (d. 1973) served as Wakils of Avatullah Hakim and since then all the Chairmen of the Africa Federation have served as wakils of the Maria of the time.

At the inception of the WF in 1976, Marhum Ayatullah Syed Qasim El-Khui granted the wakalat to Marhum Mulla Asoher as its first President and then to his successor. Haii Haider Haii. With the passing away of Avatullah Khui, on 8th August 1992, most of the Community made ruly towards the person of Avatullah Syed Muhammad Redha Gulpayghani (d. 1992),

When Ayatullah Gulpaygani, and then Ayatullah Araki, passed away, the consensus of Ahlul Khibra descended upon the person of Avatullah Sved Ali al-Seestani as the Maria', He granted Marhum Mulla Asgher a walakat' [3]. Subsequently, when Mulla Asgher passed away in March 21, 2000, the wakalat was reissued to the author of this article (and upon the election of the current President, Dr Ahmed Hassam, the wakalat was duly issued to him on a similar basis.)

The foregoing account of the relationship of the Khoia Community serves as a backdrop to a model relationship between a Maria and the mugallideen; a century old relationship and a connection with Najaf or Qum, wherever the marja resided. This has been reciprocated by an acknowledgement, by the Maraje, of the religiosity and compliance of the Khoia Community and this aspect has been one of the key factors resulting in institutions. like that of the Khoia Community, as some of the best organized and well run in the entire Shia World.

The founders of the WF began with a clear vision that the WF was formed to cater to religious, and consequently to the social, needs of the community, in order to fulfill our 'collective obligations' (waiibe Kifai). In 1990, defining this vision the Founding President of the WF, Marhum Mulla Asoher stated: "A united community where every act of goodwill is propelled and driven by sincere intention to please Allah and none else. We need a society where Tagwa is way of life, where Amrbil Maruf and Nahi Anil Munkar is the norm and practice. We need a society where the youths are saved from the rising tide of Kufr and its influence, where our men and women follow Shariah with pride and without apology. And rise above the mean and the mediocre to that which is high

Thus the underlying ethos of our Community has been consistent right form the outset. All our organizations are in the service of Imame Zamana (A.S. May Allah hasten his reappearance). And it is in the service of our Imam. that we seek the patronage and guidance of his naibs -

From the preceding historical review, it is explicit that the KSI Community has benefited tremendously by way of its contacts with and support of the Maraie. From the time of Avatullah Zainul Abedin Mazandarani in the 1800s, to the

present Marja, Ayatullah Seestani (may Allah keep him) the progress of the KSI Community today and the very existence of the WF is a living testimony of the impact of Mariaivvat upon the stability and unity of the Community. The Maraie have nurtured and supported the leaders elected by our Community demonstrating that they understand that a leadership emerging from within a Community is best placed to understand and address the internal challenges. With the help and guidance of these Maraie, the World Federation has been a major player in the affairs of the Ummah at large. The legacy of serving the Community, and Humanity, has been acknowledged and praised by all the maraie.

It is in this context, that the recent meeting of the President of the WF, and other leaders, with Ayatullah Seestani, while he was in London, needs to be

He asked Dr Hassam, the President of the WF, to convey his salaams and duas to mumineen, and to thank them for their concern for his health. He also asked mumineen to continue praying for him and advised us to always remain steadfast on the path of the Ahlulbyat (AS).

When the President asked for guidance on the recent events in Naiaf. Agha responded by asking the mumineen to pray for a guick and peaceful resolution of the conflict. Once peace returns to Iraq, mumineen should assist in the rebuilding of the Hawza Ilmiya and any other infrastructure that have been destroyed over the years. He also advised that "mumineen should not be involved in any political activities."

When a young man of the Khoia community, Altaf Dava was blessed to have an audience with the Ayatullah, he advised him, and those with him, to follow in the footsteps of their forefathers and continue the work done. They should continue to maintain the future of the organization in the same principles that it is currently run. Specifically he said 'I pray to Allah (SWT) that he may continue to guide you and the youth of the Khoia community to serve in His way.' He then advised them 'not to get side tracked from our goals and objectives by politics and other non-essential distractions that may usurp our time and energy and not result in any fruitful

To a delegation from Paris, comprising of Br Ivavar Vasram and friends, he advised that "(sic) language and culture unify and bring people together in their own family. This provides the religious attachment and its principles to be transmitted from generation to generation. The absence of sense of partnership and unity will certainly lead to a dispersion of the people in their own community after two or three generations. Consequently, the religious interest and its spread will diminish. This will lead the community to deviate and (in the end) become lost."

Such profound words require neither elaboration nor interpretation. The clarity is illuminating. The advice regarding culture and language, a vindication of the way the Khoja's function organizationally. To those, who continue to ventilate, in cyberspace, maligning the Khojas and more distressingly questioning the word of the Marja, let me say this: Perhaps they need to reappraise themselves on the concept of Marjaiyah and the role of the Marja as taught to us by the school of Ahlul bait (AS). Through the institution of litehad., our maraie are there to guide on issues mumineen face in different eras. However, the onus is on us to convey our challenges and to seek their guidance. Then, having sought their guidance, to then follow it whole-heartedly.

Therefore, as he has advised, let us pray for the safety of all, stay steadfast on the path of Ahlul Bait (AS) and not be distracted by fruitless activities like cyberspace debates, cyberghiba and cybertohmat. Much needs to be done in real space by serving humanity and the community starting with our own families and neighbours and, to promote the positive teaching of Ahlul Bait (AS).

As Imam Kadhim, (AS) advised his companion: "O Hisham! If there is a walnut in your hand and people say that it is a pearl, their saving will not benefit you in any way when you know that it is actually a walnut. And if there is a pearl in your hand and people say that it is a walnut, their saying will not harm you in any way when you know that it is actually a pearl". (Tuhaf al-'Ugool)

Let us remind ourselves of the promise of Almighty Allah in Surah Al-Ankabut (69): Wallazina Jaahadu Fiina Lanahdiyannhum Subulana : And as for those who strive hard for Us, We will certainly

IEB appoints Sheikh Saleem Bhimii to translate the commentary of the Noble Quran into English

The IEB of the World Federation has commissioned the translation of the commentary of the Noble Quran into English, called The Message of the Quran. This is a ten-volume encyclopaedia, which presents Usul-e-Din in detail, drawn from the Noble Quran. It was written by one of the leading Marajae Taglid living in Qum. Avatullah Nasir Makarim Shirazi.

The translator, Sheikh Saleem Bhimii, was born in Fort Rae, NWT, Canada in 1972. After completing his secular studies in Edmonton, Alberta, he migrated to Qum. Iran with his wife, Arifa Hudda to study in the Hawza. After four years of study, they returned home and settled in Kitchener, Ontario, Canada, Sheikh Saleem has translated over 20 books into English, one of them being a compendium of Juristic rulings on family planning in Islam, which was commissioned by the Ministry of Health and Education of the Islamic Republic of Iran with support from the United Nations Population Fund (UNFPA). He currently directs the Islamic Publishing House (www.iph.ca) and also translates articles for Al-Fath Al-Mubin Publications (www.al-mubin.org).

IEB publishes commentary on Surah al Hujarat and Suratul Jinn

The IEB of the World Federation in conjunction with the Islamic Humanitarian Service has published Avatullah Jafar Subhani's work in English, which was translated by Sheikh Saleem Bhimii. This will Inshallah help English speaking students of the Quran to study the moral and ethical concepts of Islam from it's original source.

Surah al Hujurat, the forty-ninth chapter of the Quran lays out many of the social-ethical concepts in Islam. It covers various themes from submission and obedience

to Almighty Allah, and His Messenger, Prophet Muhammad (Peace be Upon Him), to the status and honour of the Prophet in the eyes of Allah. It talks about the brotherhood of the Muslims and the ethical duties that they have towards one another. In addition, it emphasises on the concerns that Muslims should have for solving internal disputes and for supporting justice against injustice. It presents the equality among the believers, irrespective of their ethnic and racial differences. It also highlights the importance of spiritual conviction (Iman) over physical submission (Islam).

The IFB has also published Surah Jinn, based on Avatullah Nasir Makarim Shirazi's work extracted from Tafsir-e-Namuna. The work, which was translated by Shaykh Saleem Bhimji, will help English speaking students to undertake an in-depth investigation into

"Ilmul Ghaib", or Knowledge of the Unseen, Knowledge of the Unseen is only with Allah (Glorified and Exalted is He) and those individuals whom He decides to inform about these matters. This commentary is presented in a way, which seeks to clear out any misconceptions and misunderstandings that surround this important topic.

Women's Desk take charge of 'Marriage **Advisory Council'**

The Women's Desk (WD) of the World Federation has been given the heavy task of reviving the long dormant 'Marriage Advisory Council'. After a successful 'Marriage Forum' and Workshops held in Dubai at the WF Triennial Conference, during which over 150 women from Jamaats all over the world shared their views on various marital issues, the Women's Desk has now embarked on researching possibilities to find answers and solutions to the many questions raised. Feedback from the conference showed that our community urgently needed to help our youngsters all over the world in making the right, informed choices on selecting their life partner. Many avenues were discussed and all present agreed that an Internet Matchmaking site was necessary to help those who needed it, albeit with some caution. It was also agreed that more needed to be done to educate our

community overall on marital issues. The idea of 'Pre-Marriage Counselling' and 'Training for Marriage Educators' was also discussed and it was highly recommended that these courses be attended by both male and female members of our community

In view of all this. WD has undertaken to deliver the following tasks during the course of this year and will be working closely with the YND and IEB:

- A) Develop an Internet Matchmaking portal to help with spouse selection.
- B) Setting up of a Template for Marriage Committee Structures with guidelines and person specifications with roles and responsibilities.
- C) Working on 'Training the Trainers' a Training Programme for 'Marriage Educators'.
- D) Working on a Module for 'Couples Embarking on Marriage' for use in Training sessions by Marriage Educators.

Working on Extension Modules for Madrassahs on Spouse Selection and Marriage for use in Madrassahs. WD has already started putting together a team of workers to develop this programme and is looking to recruit more members. Women's Desk organise Marriage Training Programme

The Women's Desk organised a three day Training Programme for 'Marriage Educators', Islamic lecturers and trainers from the 'Marriage Care' organisation ran this course jointly. The training covered a wide range of topics and aimed to provide participants with the

More than 25 participants from different Jamaats in the UK as well as from Dubai had enrolled for the programme, which took place on May 28th to 30th in Milton Keynes. Participants learned to help couples sustain their relationship using different methods and approaches and to be able to guide them through the initial stages of their married life. Topics that were covered included Commitment, Conflict Management, Communication, Islamic perspective on Sex and Spirituality. With the evaluation and feedback from this course, the Women's Desk hopes to run similar courses for Jamaats in other parts of the world. Zainabiya High School produce exceptional results

The Zainabiva High School in Alipur, 40 miles from Bangalore, India, obtained exceptional results making it the number one school in the Kolar District. Of the 18 students who took the SSC examination (equivalent to the British GCSE Examination); 2 students obtained a distinction, 13 students obtained a 1st class grade, 3 students obtained a higher 2nd class grade. This school is following the Indian system of education. In this system, after completing the 10th grade at the age of 15/16 years, the students need to pass the Secondary School Certificate (SSC) examinations to proceed further into higher education. They are examined on the seven subjects which include a Primary and Secondary Language, Mathematics, Science, Social Studies, Physical Education. Typewriting, and Computer Studies.

The school, which was built by the ZCSS of the World Federation, has 575 children and runs classes from Lower Kindergarten through to the 10th standard. The Imamia Education & Welfare Trust of Bangalore currently manages it. The attainment of such high standards is a tribute to the school's Principal, Br. S.A. SAB's "Spread the Warmth" Campaign

On the auspicious occasion of Eid-e-Mubahila, The Seniors Advisory Board launched the Hadith e Kisa Blanket Drive "Spread the Warmth" Campaign. This initiative was aimed at raising funds for our senior citizens around the world, so that they can purchase warm blankets to keep them protected from the cold winter nights.

The Seniors Advisory Board will be holding a number of blanket drives that are region specific. The first region was Bihar, which is a state in the eastern region of India. It is a flood prone region and one of the most underdeveloped regions in the country. Of the 86 million people who live in Bihar, Muslims account for about 15% of the total population. Patna, the capital city, has 10,000 Shia Muslims of whom 95% live in abject poverty and gross deprivation. They lack basic facilities like housing, sanitation, and clean water. Health care is non-existent. Most people are unemployed and getting enough to eat is a daily struggle. Most of these individuals do not have any heating systems in their homes. Those that do have blankets have ones which are torn and no longer provide any warmth. Bihar experiences extreme climates, as shown in the reference below.

"In January 2003, a cold wave hit the state of Bihar, For the first time in 40 years, temperatures dropped to almost zero degrees centigrade. As a result, Bihar was reported to have the second highest number of casualties - 100 in one month alone."

The equipment, worth over £25,000. included the much-needed supplies like incubators for premature babies, ultrasound machines and its gel packs, glucometers, gynaecologist equipment, blood transfusion sets and other essential medications.

This donation was administered by the Chairman of the Medical Advisory Board, Dr. Mohammed Taki Walii and Mr. Aliasgar Rajbhai. Most of these items were bought by the World Federation and several generous donors.

Report on MAB Haj Medical Mission

As done every year, the MAB of the World Federation sends a medical team to Haii with the aim of serving the Huijai if they fall ill. This year the team consisted of Dr Gulamabbas Raipar of Trollhattan, Sweden, Mr Aliasgar Rajbhai of Birmingham, UK, Dr Asad Lakhani of Mumbai, India and Dr Ageel Moosa of Karachi, Pakistan, The groups were given medications, some provided with regular clinics and some were helped with regular visits by doctors. Those large groups without accompanying doctors e.g. groups from Madagascar were found to be particularly needy and were helped appropriately. In Arafat, Muzdalifah and Mina, help was made available when necessary without duplicating services. Very serious patients with life threatening conditions were attended to in Madina and Makkah. Patients were given prompt attention and a full course of medicines was provided free of charge - a gift from The World Federation. Hujjaj appreciated the services provided by the World Federation.

Like last year, the team co-operated with doctors from Imamia Medics International and a full and comprehensive service was provided to the Huijai. A meeting of all the doctors was held at the end and mutual views were expressed. All the doctors expressed a wish to work in full co-operation and partnership. Feedback from the team and groups indicates that Alhamdulillah, our communities worldwide are realising the importance of having a doctor in their groups. MAB expresses sincere appreciation to the team of volunteers for their generosity and willingness to help the sick and needy at all times.
